5 Year Forecast

Treasurer Beth Collier presented the five-year financial forecast to the Board of Education. She summarized the improved financial position as a result of an 8% reduction in insurance premiums for 2016-17 (compared to a 15% average annual increase experienced over the last 5 years), not replacing two positions that recently retired, and incorporating new Grandview Yard revenue projections provided by the City of Grandview Heights. While these factors have improved the financial position of the District, she also explained that Grandview Heights is a "guarantee" district in terms of state funding and there is a risk those guarantee funds (approximately \$1,000,000 per year) could be phased-out or eliminated in a future biennial budget.

Committee Reports

Mr. Truett reported on the following from the PI Committee:

- Old vehicles will be sold soon (3 vans and 1 truck);
- Turf replacement is being planned for fall 2016;
- Baseball field has some safety issues that need addressed;
- FutureThink is currently performing an enrollment projection for the district; and
- There is a need to have an athletic facility assessment in conjunction with the building assessment recently completed.

Mr. Truett also reported the following on behalf of the Facility Oversight Committee:

- The first building level meetings are in process;
- Harrison Planning Group & Grandview Height Schools have ended their partnership; and
- Facility Task Force is meeting next Wednesday, October 26th to discuss next steps.

Stephanie Evans reported the Education Foundation has set the date of the next gala for February 18, 2017.

Melissa Palmisciano reported that she is planning to attend the delegate meeting at the upcoming OSBA Capital Conference.

Superintendent's Report

Teaching and Learning

- Stevenson Elementary and Syntero are partnering to provide two Wellness Mini Courses to grades K-3. "Worry Warriors" focuses on anxiety and worries and explains physical and cognitive indicators of anxiety and helps students learn strategies to manage those symptoms. "Team Adventure" will help students strengthen skills necessary to effectively work with their peers toward common goals. These mini courses also support the following learning attributes: resourcefulness, perseverance, empathy, communication, collaboration, and respect.
- All Science Day will be October 21 at Stevenson Elementary. Students will spend the day immersed in science with hands-on activities.
- Parent Education Opportunity: Syntero clinicians will present on the important topic of mental health on Thursday, October 20, 2016, beginning at 7:15 p.m. in the Brotherhood of Rooks Media Center. Parents and guardians will learn what students are learning so that they are able to have more meaningful and productive conversations with their students. Topics of discussion will be mental health issues facing students today, a review of the information provided in the Signs of Suicide student curriculum, and parent resources.

Learning through the Arts:
