Superintendent's Report Teaching and Learning

On Friday, January 19, Stevenson Elementary hosted an event called Mathematical Mindset where parents had the opportunity to learn more about the math curriculum and instruction. The event also served to strengthen home school collaboration to ensure a strong math foundation for all students. Prinicpal Angie Ullum and Instructional Specialist Amie Goode led the presentation. After the presentation parents participated in math workshops in their child's classroom.

The Brain BLAST is Thursday, February 22, from 6:00-7:30 p.m. at the Edison/Larry Larson Commons. This event celebrates our students from the scientific to the terrific!

Stevenson Elementary first graders will celebrate Puerto Rico Night February 15 at their First Grade Open House. The event will feature student work from their related arts classes including Spanish, Music, Art, and Library, traditional Puerto Rican snacks, and students in a Carnival parade.

Following the Expo on March 1st, Kindergarten and Child Care/Kids' Club registrations will be open for the summer and 2018-2019 school year.

A Kindergarten Parent Information Night will be held March 8, 2018, at 6:30 p.m. at Stevenson Elementary.

Edison Intermediate fourth grader teachers are holding optional "office hours" Thursdays afterschool. Students are encouraged to touch base with their teachers, ask questions about homework/projects, finish class work, use classroom space to read/work quietly, or access technology for school- related tasks. Students who attend office hours are building learning attributes and educational advocacy and independent learning skills. Although attendance at "Office Hours" is optional, a significant portion of our students have attended at least one session. Attendance has averaged about 25% of the students per week.

GHHS has committed to a partnership with Metro High School/PAST Foundation Learning Lab to offer pathway opportunities to students in the following areas A) Growth and development pathway B) Bodies pathway C) Energy pathway D) Design pathway and E) Digital pathway.
