MINUTES OF THE GRANDVIEW HEIGHTS SCHOOLS BOARD OF EDUCATION Regular Meeting – March 8, 2018

The Grandview Heights Schools Board of Education met in regular session at the Brotherhood of Rooks Media Center in the Grandview Heights High School. The audio recording of this meeting is on file at the office of the Board of Education.

Pledge of Allegiance was said and a moment of silent meditation was held.

Presentation:

Mrs. Sara Hager and 6th grade students from the EI/LMS Service Learning Community Action Team presented to the Board of Education on a "No Waste Friday" initiative they started to help address food disparity in central Ohio. The students gather food during their Friday lunch periods that was not eaten and deliver it to a local food pantry. Students explained how the program began last year and how it has continued. They also answered questions about what they have learned from their experience.

Committee Reports

- **Finance Committee** Ms. Beth Collier reported that a new Finance Committee was being organized to include review and prioritization of Permanent Improvement Levy needs/expenditures, but it will also have a broader scope to include reviewing all facets of the District's financial operations.
- **Policy Committee** Mrs. Palmisciano reported the Policy Committee met today to review recommended policy changes and they will be included on the April board meeting agenda as a first reading. Mr. Truett suggested the board consider evaluating its policy on adult weapons. He indicated his personal opinion is the board should think about taking a stronger position in its policy.
- **OSBA/Legislative Liaison** Ms. Wassmuth reported on proposed legislation (HB 512) which would combine the Ohio Department of Education, the Board of Regents, and the Office of Workforce Development. It was noted and discussed that the Ohio School Boards Association is encouraging districts to oppose the measure.
- City of Grandview Heights Mrs. Palmisciano reported updates on the following items:
 - o Planning Commission has received a proposal for additional single family homes in Grandview Yard; and
 - Marble Cliff has received a proposal to develop the old mansion property on West 5th Ave. into 62 residential units.

Superintendent's Report

Teaching and Learning

Our district is committed to the integration of health and wellness in our curriculum in all of our buildings. A few examples include:

- Stevenson Elementary School Counselor Stephanie Doran and Syntero's Larysa Gilbert will offer the following small groups sessions: Worry Warriors, Conflict Resolution, Raise for Boys, and Leadership Group. These needs based groups, based on the analysis of the bi-monthly rating scales, are designed to support the social and emotional growth of our students.
- Larson Middle School seventh grade students have participated in Signs of Suicide (SOS). SOS is unique among school- based suicide prevention programs as it incorporates two prominent suicide prevention strategies into a single program: an educational curriculum that raises awareness about suicide and depression and a brief screening for depression. The program uses a simple acronym, ACT (Acknowledge, Care, Tell), to teach students action steps to take if they encounter a situation that requires help from a trusted adult. All students completed a survey indicating if they themselves might be struggling during this time. Those who demonstrated a need met individually with School Counselor Abby Mally who also provided families with resources for support.
- In conjunction with Syntero, Grandview Heights High School held their second junior/senior parent book study on Tuesday, February 27. The discussion focused on the importance of personal connectivity and the impact it has on mental health and the college transition and how to support students for success.

April 9 will be "Pathways and Passions" Day at Grandview Heights High School. This will be a targeted career speaker series day based on the careers that students have the most interest in. It will be designed to be a walk to model and will be combined with a rich learning experience in the second half of the day for students to learn and explore passions in sessions led by staff and students.

Intervention Specialist Teacher Brandon Theiss and his students have opened their Bobcat Beverage Coffee House. Every Friday morning beginning at 7:30 a.m. students, staff, and community members can get a fresh cup of coffee, tea, or a frappe for just \$1. Our students are gaining work/life skills and are doing a great job of preparing beverages for customers. Their business is quickly growing!

The Grandview Heights High Schools Bands will present their *Music in our Schools Month* concert on Tuesday, March 13, 2018, at 7:00 p.m. At this year's MIOSM concert the members of the Grandview Heights Concert Band will honor any/all students, families, and communities affected by school violence with the performance of Frank Ticheli's *An American Elegy*.

Discussion Topics

- 1. Property Value Appeals Mr. Derek Haggerty was present to explain to the Board of Education the process for property value appeals and counter-appeals. The Board of Education then discussed the possibility of creating a policy for responding to property value appeals and for considering appealing values of commercial properties when sales of such properties reveal a significant difference from the taxable value. The Board asked that the Finance Committee meet to review the appeals in more detail and make a recommendation on how to proceed.
- 2. Potential resolution to support the Ohio Fairness Act and the effort to change Ohio's anti-discrimination laws to include sexual orientation, gender identity, and gender expressions as protected classes Mrs. Palmisciano explained that City Council President Gretta Kearns asked the Board of Education if it was interested in joining city council in a public resolution supporting this effort. Mr. Truett stated that he was in favor of the idea of supporting this. Mr. Bode stated that while he believes the Board of Education may not need to take a position on every issue that is presented, he does feel that this directly impacts our students and, therefore, the Board should consider supporting this. He also stated that it is evident that this is important to our students as they formulated a Gay Straight Alliance student activity group a couple years ago, and since it's important to them, it should be important to the Board of Education.
- 3. Quality Profile The Board discussed the need to review the draft Quality Profile and agreed that it should be done at a special work session meeting to allow adequate time to thoroughly review the document.
